Item 5.07 Submission of Matters to a Vote of Security Holders

On May 25, 2023, Compass Diversified Holdings (the "Trust") and Compass Group Diversified Holdings LLC (the "Company") (NYSE: CODI) (collectively "CODI") held their 2023 Annual Meeting of Shareholders (the "Annual Meeting"), via virtual webcast. A total of 72,202,729 shares of the Company's common stock were entitled to vote as of March 28, 2023, the record date for the Annual Meeting. There were 61,668,261 shares present in person or by proxy, constituting a quorum, at the Annual Meeting, at which the shareholders were asked to vote on three (3) proposals. Set forth below are the matters acted upon by the shareholders and the final voting results of each such proposal.

Proposal 1. Election of Directors

With respect to the election of the following nominees as directors of the Company to hold office for a one-year term, ending at the 2024 Annual Meeting, the shareholders voted as set forth in the table below:
